TERMS AND CONDITIONS

1. Information on how to enter this Promotion and Prize details form part of these Terms and Conditions of entry (**Terms**). These Terms apply to the Promotion and entry into the Promotion is deemed acceptance of these Terms.
2. The promoter is 101 Collins Street Pty Ltd (ACN 004 582 423) of 101 Collins Street, Melbourne VIC 3000, Australia (**Promoter**).
3. The Promotion will be open from Wednesday, 3 November 2021 at 12.00pm AEST and will close on Tuesday, 30 November 2021 at 4pm (**Promotion Period**).
4. Entry is open to Victorian residents only aged 18 years and over who are either tenants, or employees of a tenant, of 101 Collins Street and either existing subscribers to the 101 Collins Street mailing list, or opt-in to the 101 Collins Street mailing list*, at the time of submitting an entry, excluding:
 - (a) management, employees, directors and contractors of the Promoter, its related entities, and other agencies, firms or companies associated with the Promotion (including suppliers of Prizes);
 - (b) a spouse, de-facto spouse, parent, guardian, child or sibling of a person referred to in paragraph 4(a) of these Terms;
 - (c) persons who have used or attempted to use any more than one name in order to qualify to win a promotion run by or on behalf of the Promoter (except in the case of a legal change of name); and
 - (d) persons who have breached the terms and conditions of any promotion run by or on behalf of the Promoter,

(Eligible Entrants).

The persons referred to in paragraph 4(b) of these Terms includes natural and non-natural relations (in the opinion of the Promoter) and the Promoter is responsible for determining whether a person is an Eligible Entrant in its absolute discretion. By entering this Promotion you represent that you are eligible to enter.

5. To enter the Promotion and be eligible to win, Eligible Entrants must, during the Promotion Period:

 - (b) correctly fill in the entry form;

 - (e) agree to these terms and conditions and click submit,
6. There is a limit of one entry per Eligible Entrant during the Promotion Period. The use of any automated entry software or any other mechanical or electronic means that allows an entrant to automatically enter the Promotion repeatedly is prohibited and will render entries submitted using such means invalid.

7. Eligible Entrants can only enter the Promotion in their own name.
8. The Promoter accepts no responsibility for any entries not received for any reason during the Promotion Period. Entries will be deemed to be accepted at the time of receipt by the Promoter. No responsibility will be taken for lost, late or misdirected entries or entries not received for any reason. The Promoter is not responsible for technical difficulties with the entry mechanism and does not warrant that the entry mechanism will be available at all times.
9. Incomplete, illegible, indecipherable or incorrect entries are invalid.
10. Any entrant who, in the opinion of the Promoter, tampers or interferes with the entry mechanism in any way, or who does not properly comply with the entry process, will be ineligible to win. The Promoter reserves the right to disqualify entries in the event of non-compliance with these Terms.
11. A computerised, random draw (**Draw**) for the Prizes will take place on Thursday, 2 December 2021 at 9am AEST (**Draw Date**) at 101 Collins Street, Melbourne VIC 3000 (**Draw Location**) in accordance with clauses 12 and 14 below.
12. The Draw will be conducted by the Promoter.
13. The Eligible Entrant with the first [**one**] valid Eligible Entry drawn will win a Prize (**Winner**).
14. The Prize is three (3) bottles of 750ml Penfolds Grange. Including the following vintages: 1991, 2001 and 2011. Each bottle will be presented in individual wooden boxes. The prize also includes one (1) copy of Penfolds book "Rewards of Patience". The total prize pack is valued at \$3329.
15. The total prize pool consists of 1 prize pack that includes three (3) 750ml bottles of Penfolds Grange red wine, and one (1) Penfolds book valued at combined total of \$3329 (including GST).

20. The Promoter reserves the right to request that a Winner provides proof of his / her identity, residency, employer, position and / or age prior to awarding a Prize. Proof of identification, residency, employer and /or age considered suitable for verification is at the discretion of the Promoter. In the event that the Winner cannot provide suitable proof in the timeframe required by the Promoter, the Winner will forfeit the Prize and no substitute will be offered.
21. If, after making all reasonable efforts to identify the winner of the Prize, the Promoter is unable to contact the Winner to claim fulfilment of the Prize by Thursday, 30 December or

the Winner cannot provide suitable proof as required by clause 20, a manual random / computerised re-draw for the Prize will take place at 9 am AEST on Tuesday, 11 January (**Re-draw Date**) at the Draw Location, subject to any written directions given by State and Territory gaming departments. The re-draw Prize winner will be notified by phone and in writing on Tuesday, 11 January. The re-draw winner's details will be published in INSERT WEBSITE and Instagram.

22. The Prize will be available for the Winner to collect from 101 Collins street concierge within 28 days of the Draw Date or Re-draw Date, as applicable.
23. The Promoter shall not be liable for any Prize that may be lost, stolen, forged, damaged or tampered with in any way before it reaches the Winner.
24. In the event that the Promoter is unable to supply the Prize, the Promoter reserves the right to supply an alternative prize of the same or greater value, subject to any written directions given by State or Territory gaming departments.
25. The Promoter's decision is final on all matters and no correspondence will be entered into.
26. Eligible Entrants can also gain access to, update or correct any personal information held by contacting the Promoter at the details listed in paragraph 2 of these Terms. The Promoter's privacy policy also contains information about how Eligible Entrants can make a complaint. All personal information will be stored at the office of the Promoter.

The Promoter is not responsible for any technical malfunctions or problems with internet or network congestion, including injury or damage to a participant's or any other person's computer related to participation in this Promotion and problems with transmission of entries and / or emails over the internet, acts in violation of these terms and conditions,

acts in a disruptive manner, or acts with the intent to annoy, abuse, threaten or harass any other person.

30. Acceptance and use of the Prize is subject to any terms and conditions imposed by those involved in providing goods and/or services as part of or in connection with the Prize (**Third Party Terms**). The Winner is responsible for complying with all applicable Third Party Terms, and bears all risk associated with failure to comply with any of them. The Promoter assumes no liability (and will provide no compensation) as a result of any failure to comply with any Third Party Terms.
31. All costs associated or arising in connection with participating in the Promotion and the Prize are the responsibility of the Eligible Entrants. Any costs associated with accessing the internet are the Eligible Entrant's responsibility, and depend on the internet service provider used.

The Promoter will not be liable for any loss or damage whatsoever which is suffered (including but not limited to indirect or consequential loss) or for personal injury which is suffered or sustained, in connection with this Promotion or as a result of accepting or using the Prize, except for any liability which cannot be excluded by law.
